Hello Fellow Shareholders,


I send greetings to you and your family wherever you may be. Summer is approaching and we are beginning to enjoy longer and much warmer days in Nome.

"I hope I am able to contribute more to our shareholders. By remembering our past and working together, we can continue to build a strong future."


Perry Mendenhall's passion for the next generation is evident in his life-long dedication to education. Perry's expertise about the land and his career in K-12 education have earned him great respect from not only the Nome community, but also from Sitnasuak. Sitnasuak Elders' Committee has named Perry as Elder of the Year. Sitnasuak is ever grateful for his generous sharing of knowledge.

Perry was born in Nome in 1946 to Dolly N. Mendenhall of Deering, Alaska and Billy Sheldon of Noorvik, Alaska. He was raised by his mother, Dolly. Perry spent most of his summers out in the country with his grandmother, Grace Mendenhall, where he began to build his ever growing relationship with the lands of the Seward Peninsula. He fondly remembers following the tracks of bears, hunting in the mountains and seining salmon.

After graduating from Glennallen High School in 1964, Perry went on to receive a degree in Bible Theology from Central Bible College in Missouri, a degree in K-12 Education from the University of Alaska Fairbanks (UAF), and a Masters of Administration Curriculum from the University of Oregon. Perry has taught in several small communities including Teller and Gambell, just to name a few. He also taught over 10 years as a UAF instructor of Teacher Education on a statewide basis in a distant degree program.

"Being a teacher has allowed me to watch, to be patient, and to help our people," said Perry.

Perry founded the Kawerak Boarding Home Program. This program placed children from rural Alaska into Nome's educational system, where each student had the opportunity to receive a quality education. The Kawerak Boarding Home Program led to the development of Nome Beltz High School. Perry



also played a role in the founding of Kawerak, Inc. alongside Jerome Trigg and Tim Towarak. Perry married Nancy Mendenhall in 1974. He and Nancy raised five children: Eli Mendenhall, Frank McFarland, Dan Thomas, Lesley Thomas and Robin Thomas. Perry and Nancy have 14 beautiful grandchildren and great-grandchildren.

Perry recognizes his Elders as being the foundation of his knowledge, which he aims to continue to share. "I hope I am able to contribute more to our shareholders. By remembering our past and working together, we can continue to build a strong future." Together with fellow Sitnasuak shareholders, Perry's goal is to protect our Sitnasuak lands and sustainable resources and keep our cultural traditions alive.

Sitnasuak Annual Meeting information

What is the purpose of the Annual Meeting of Shareholders? The Annual Meeting of Shareholders is a great opportunity to hear reports from the Chairman, President, Treasurer, auditors, committees, and subsidiaries. The approval of the meeting minutes from the 2014 Annual Meeting of Shareholders will take place, which were included in your proxy packet mailed out by the Corporation in late April. Furthermore, four Directors for terms of three years each will be elected.

When and where will the meeting take place? The Annual Meeting of Shareholders will be held on Saturday, June 6, 2015, 10:00 a.m., at Nome Elementary School in Nome, Alaska.

Can I still vote without attending the meeting? Yes. Shareholders who cannot attend the meeting are requested to list their votes, sign, and date and return their proxy card in the prepaid envelope, which was enclosed in your proxy packet. Your proxy card must be received at the Election Judge deposit box located at the Sitnasuak Native Corporation office in Nome or by the Election Judge by 5:00 p.m. on Wednesday, June 3, 2015.

Can I vote the day of the meeting? Yes. Shareholders must register in person to vote the day of the meeting. Registration will be open at Nome Elementary School from 8:00 a.m. until 11:00 a.m. on June 6, 2015. You must register during the registration period and attend the meeting in order to cast your votes.

Is it possible to recast my votes in person at the meeting although I sent in my proxy card beforehand? Yes. You have the opportunity to revoke your proxy card at any time before the meeting and vote in person.

What happens to my shares of stock if I do not vote? If you do not specify your votes to director(s) nominees on the proxy, the Proxy Committee will divide your votes equally among the eight nominees for the Board of Directors. The Proxy Committee consists of Crystal Andersen-Booth, Louie Green, Jr., and Jason Evans.

Nanuaq Development project update: Rilke Schule



PROJECT SUMMARY

Rilke Schule German School of Arts & Sciences is a kindergarten through 8th grade German immersion charter school in the Anchorage School District. A new 39,500 sq. ft. building is being constructed to provide long term space for the school.

The site is located on East 64th Avenue, opposite of Burlwood Street in Anchorage. The building exterior will be clad with insulated metal building panels, providing the school with an efficient envelope that is also extremely durable in the Alaskan climate. The entry canopy is brightly colored to give the school a playful identity, while the transparent entry allows light to filter into the lobby creating a warm and welcoming feeling for the community. Each classroom and office space has access to natural light that contributes to the energy efficiency of the building, occupant health, and creates an environment where students can succeed. The school is scheduled to be completed in the fall of 2015.

DESIGN

Final permit drawings have been submitted to the Municipality of Anchorage (MOA). The design team continues to respond to MOA review comments.

We received review comments on the submitted Traffic Impact Analysis from both MOA and DOT. Resubmittal was required and was completed last week. The design team continues to review material submittals from Criterion General.

PERMITTING

We are using a phased permitting approach, which allows certain phases of construction to begin before full building permit is issued. We currently have a fill and grade as well as footing and foundation permits. We expect to have the remaining permit issues addressed shortly and a full building permit will be issued. We have also completed our permit submittal, approval and pre-construction conference with AWWU on the water mainline extension to serve the property. As soon as Right-of-Way opens for the season the civil contractor will begin water line installation in the street.

CONSTRUCTION

The last month has seen great progress on the site. Foundation footings have been formed, poured and stripped. Fill has been brought in and compacted to bottom of slab in a majority of the building area. Underground electric continues to be installed in the remainder of the slab area along with reinforcing steel, with the next slab pour slated for the middle of next week.

The civil subcontractor continues to assist on site and has completed the water service on property including a new fire hydrant.

The steel building has shipped and is expected to arrive in Anchorage on schedule. Steel erection is on track to begin May 6.

OTHER ISSUES AND UPDATES

We conducted two site meetings and walkthrough with the Rilke Schule leadership in April, which we expect to continue on a bi-monthly basis throughout construction. Currently we are wrapping up cost proposals and budgets requested by Rilke Schule for enhancement options that we except to present to Rilke.

Business news:

REAL ESTATE

On May 1st Sitnasuak Native Corporation closed on the "Real Estate Center," a two story office building located in Wasilla, Alaska. The building is located just north of Target on the Palmer-Wasilla Highway adjacent to Lake Wasilla. The Real Estate Center is considered a class "A" office building and is nearly 20,000 square feet. It is a relatively new structure, which was built in 2005 and houses our subsidiary, Mat-Su Title Company.

Not only does Sitnasuak earn a good return on this investment, we now become our own landlords, keeping all rent proceeds within the organization.

You may recall that Sitnasuak sold two residential properties in Nome last December. The proceeds for this sale have been held in escrow ever since and were released May 1st (along with additional cash) to purchase the Real Estate Center in Wasilla. This investment has allowed Sitnasuak to defer significant taxes



on the sale of the properties in Nome. When compared to the properties sold in Nome, this new investment:

- is larger (more income for Sitnasuak)
- lowers our tax expense (more depreciation)
- lowers our annual maintenance cost (Wasilla property is 20+ years newer)
- has fewer tenants (commercial vs. residential) that generally stay longer

We are very pleased with our new investment, which is owned by the same company that sold the properties in Nome, Nanuaq, LLC.
